## 1 INTRODUCTION

- 1.1 Sunway is involved in a wide array of business operations, resulting in the production of diverse types of waste, such as general waste, recycled waste, and hazardous waste. Mishandling waste can lead to soil contamination through leaching, thereby degrading soil quality, causing water pollution, and increasing water toxicity, which poses risks to marine life and human health.
- 1.2 Consequently, we acknowledge our duty to ensure that waste generated from our operations is appropriately managed and disposed responsibly.

## 2 PURPOSE

- 2.1 Sunway Berhad (the “Company”) is committed to promoting circular economy solutions for the waste generated by our operations.
- 2.2 The Company’s waste management strategy follows the waste management hierarchy which prioritises the prevention of waste, followed by reduction, reuse, recycling, recovering and subsequently responsible disposal.

## 3 SCOPE

- 3.1 Sunway’s Waste Policy (the “Policy”) applies at the Group level, and may be adopted by companies dependent thereon. Companies in which the Group has an interest but do not form a part thereof, the Company will promote, through its representatives on the boards of directors thereof, the alignment of their own policies with those of the Company, such that they adhere to commitments that are consistent with those established in this Policy.

## 4 POLICY STATEMENT

- 4.1 The Company strives to deliver sustainable outcomes by initiatives relating to waste prevention, reduction, reuse, recycling, and recovery at different stages of asset life cycle:
  - a) Acquisition
  - b) Planning, design and construction
  - c) Operation and maintenance
- 4.2 The Company targets to divert 40% of waste from landfills by 2030.
- 4.3 The Company aims to reduce single use plastics generated by our businesses by promoting behavioural changes and providing alternative solutions for our shoppers, hotel guests and other stakeholders.

**5 IMPLEMENTATION**

5.1 The Company will achieve sustainable waste management by:

- a) Scaling up current sustainable waste management efforts and identifying opportunities to embark on new waste solutions.
- b) Prioritising waste prevention during the procurement of goods.
- c) Encouraging and supporting our tenants and contractors to reduce, reuse and recycle waste during their fitting-out works and operations.
- d) Measuring and monitoring waste performance during fitting-out works and operations.
